Dear Sir I

Not having heard from you directly since I saw you I take this opportunity to inform you that myself & family ^{are} in usual health. It may be that you have written but I have not received any thing from you. I should like to know how you have prospered Mr Wadleigh of our town informed me that you had succeeded tolerably well. He returned here some 4 months ago with some \$ 14000. which he says he made mostly in nine months in California. I should like to know how my affairs stand, how you got along with Mr Berry as to settlement how he prospers and all matters connected therewith if I am to realize any thing & when. I was at Laurel when your Brother & companion started he gave me the contract with James of Cincinnati but your brother said he had no books to make up the balance due me & Mr James said there was a balance due him on the contract, so I have rec'd nothing, but that makes no difference, if the little assistance it would you should be instrumental in placing you in circumstances to enable you to do as you could wish I have no fears so far as I am concerned, but I do hope you will take the time to write to me if time is not too precious. I saw a few days ago a very intelligent letter from one of the Laurel Boys in behalf of the whole in which he mentions that Mr Buckland has got ^{the} ^{of this} bearer Mr Hiram Ogle from this place is a very good citizen & mechanic & I should esteem it a favour if you would give him what information you can in regard to Oregon &c as he inclines to do business there. Mr Beaton the gentleman that was with me when you left Cincinnati for Oregon in 146 has a brother in law a German blacksmith by the name of Edg. C. Weers who went out this season who he would be glad to hear from & a letter will probably be delivered to you from Mr Ogle for him which you will confer a favour by forwarding please give my
